- The Fund is a U.S. small-mid core equity mutual fund that seeks long-term capital appreciation with similar risk levels and characteristics to its benchmark, the Russell 2500™ Index.
- The Fund invests in domestic stocks with market capitalizations similar to those included in the Russell 2500™ Index at time of purchase.
- At an individual stock level, we search for events related to significant insider buying or stock repurchases (**over-reaction**) and significant earnings surprises (**under-reaction**), and other news that demonstrate investor misbehavior.

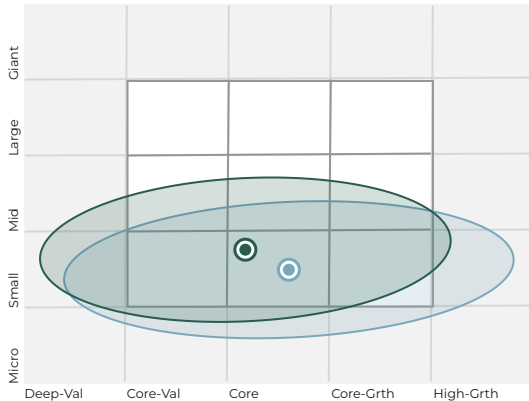

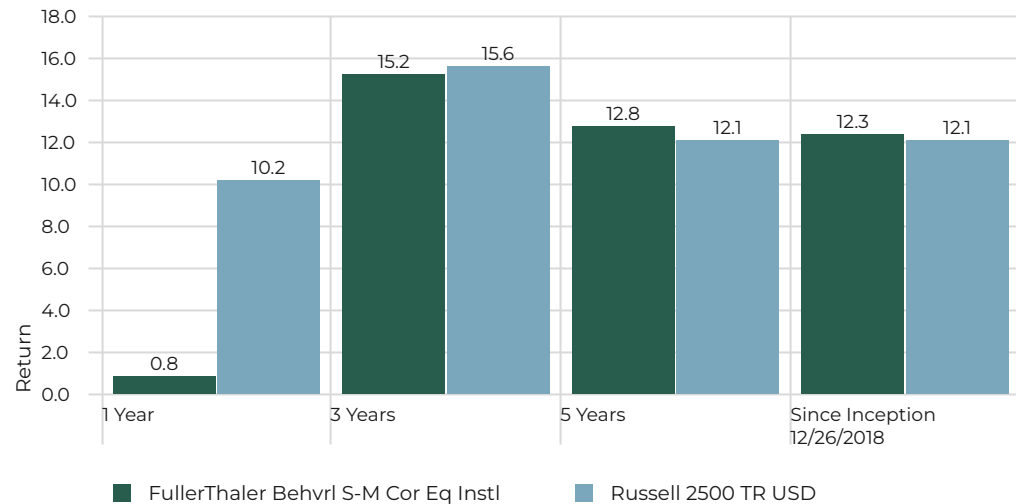
● FullerThaler Behvrl S-M Cor Eq Instl ● Russell 2500 TR USD
